For the purposes of the existence of professional competence, the competitors, if Italian citizens or other member states resident in Italy, must be entered in the register of the CCIAA. for activities related to the object of the tender. In order to demonstrate this requirement, it is necessary to provide a copy of the certificate of registration to the CCIAA. of competence, or a certified copy of the same by a declaration as per DPR 445/2000, or self-certification pursuant to DPR 445/2000 containing all the data relating to his position at the Chamber of Commerce as required. For temporary groupings or ordinary consortia already established or to be established, for the aggregation of network companies, or EEIGs, the registration to the above Register of companies must be held by each of the companies grouped together or wishing to group, consortium or intend to consortia, or adhering to the network contract. In the event that the participant is not required to register with the CCIAA, the legal representative must declare self-certification according to the DPR 445/2000 the non-existence of this obligation, attaching a copy of the Articles of Incorporation and of the Articles of Association. The declarations pursuant to the DPR 445/2000 will be accompanied by a photocopy of the identity document of the Legal representative and / or the potential attorney of the Legal representative who makes the declarations. In the event that the latter is to sign, it is necessary to attach, under penalty of exclusion, a copy conforming to the original of the relative power of attorney. In case of recourse to the institution of the transfer, the competitor must attach the documentation provided for in art. 89 paragraph 1 of Legislative Decree 50/2016.

(as previously mentioned), this declaration must be given by each company, and will be commensurate with its share in the grouping.
2. Declaration concerning the global turnover and turnover of the sector, related to the sale of new factory buses, with reference to the last 3 financial years.
